Deviations of +/- 5% are possible within the legal limits for dimensions and weight information, including the weight in ready-to-drive state, the actual vehicle mass, and the technically permissible total mass.

EU legislation is thus considering the fact that there are certain fluctuations in the weight in ready-to-drive state due to fluctuations in the mass of supplied parts as well as process and weather-related factors.

Unless otherwise specified in the catalog, price lists or technical data, or unless you have agreed otherwise with your seller, the weight in ready-to-drive state is defined as follows in accordance with the Implementing Regulation (EU) 2021/535 of the Commission from 31 March 2021: Mass of the vehicle with standard equipment according to manufacturer's specifications incl. driver (75 kg), fuel tank filled to 90%, systems containing liquids filled to 100% (Implementing Regulation [EU] 2021/535 of the Commission from 31 March 2021) and, if available, the trailer equipment, the mass of the spare wheel and the tools.

Special equipment (additional equipment) and accessories increase the weight in ready-to-drive state and reduce the load. Load in the sense of the catalog specifications is defined as follows: Difference between the technically permissible total mass and the weight in ready-to-drive state. The weight of the special equipment (additional equipment) and accessories can be found in our brochure or can be requested from your dealership/seller.

The maximum number of persons indicated in each case depends on the weight and axle load. It can be reduced if special equipment (additional equipment) and accessories are fitted, so that individual seats cannot be used in favor of the load capacity. If all seats are to be used, some of the load must be dispensed with. The technically permissible total mass and the axle loads must not be exceeded.

The load capacity is reduced by the installation of special equipment (additional equipment) and accessories.

The minimum load must always be observed (Implementing Regulation [EU] 2021/535 of the Commission from 31 March 2021). The minimum load is calculated as follows: Minimum load in kg = (vehicle length in meters + maximum number of passengers + driver) x 10. In addition, the load capacity depends not only on the weight in ready-to-drive state, the actual vehicle mass (Implementing Regulation [EU] 2021/535 of the Commission from 31 March 2021), the mass of the optional equipment (additional equipment) and accessories and the technically permissible total mass, but also on the respective axle loads. A prerequisite for the utilization of the vehicle's technically possible load is a corresponding, axle load-dependent load distribution. This must be checked each time before setting off. All other regulations that are necessary for the safe operation of the vehicle must also be complied with every time the vehicle is used. Information on masses and weights is provided in accordance with the Implementing Regulation [EU] 2021/535 of the Commission from 31 March 2021, unless otherwise specified in the catalogs, price lists or technical data.
